

LEGAL NOTICE

**Improvement Ordinance No. 557-
An Ordinance to provide certain
improvements on Traffic Street,
Criterion Street and Telegraph
Road, all in the City of Prichard,
Alabama, to provide for the
kind and character of improve-
ments to be made and the meth-
od to be employed in paying for
same.**

**BE IT ORDAINED BY THE CITY
COUNCIL OF THE CITY OF
PRICHARD, ALABAMA, AS
FOLLOWS, TO-WIT:**

1. That Sanitary Sewers be constructed as follows: On Traffic Street from Bay Bridge Road to Telegraph Road, on Criterion Street from Bay Bridge Road to Telegraph Road, on Telegraph Road from Traffic Street to South Cawthon Avenue.

2. That in the construction of said sewers all necessary connections, wyes, manholes and other appurtenances, including a pumping station, be constructed, all as shown by the detail drawings, plans, specifications, and surveys and cost estimate for said work heretofore prepared by Ladd Engineering Company and on file in the office of the City Clerk of the City of Prichard. The said detail drawings, plans, specifications, profiles and surveys of said work and the cost estimate thereof, which have been exhibited to the City Council, are hereby adopted by said Council and shall remain on file in the office of the City Clerk until June 20, 1952, where affected property owners and other interested parties may see and examine the same.

3. That the said sewers be constructed of vitrified clay pipes with bituminous joints, that manholes be constructed of brick, concrete and cast iron, that the pumping station be constructed with reinforced concrete pit, frame house with asbestos siding and roofing, containing therein two "Flush-kleen" pumps, electric motors, piping, wiring and controls, and the force main shall be constructed of cast iron pipe with lead joints, all as shown on the approved plans and specifications.

4. That the cost of constructing the improvements provided for in the preceding sections shall be assessed against the properties abutting on the streets and portions thereof herein provided to be improved in the manner provided by the laws of the State of Alabama; provided: no assessment shall exceed the cost of the improvement nor the increased value of such property by reason of the special benefit derived from such improvement.

5. That the City Council of the City of Prichard will meet on the 20th day of June, 1952, at 6:00 o'clock P.M. in the City Hall to hear any objections, remonstrances or protests that may be made against the improvements provided for herein, the manner of making same, the character of materials to be used, or the method providing for the payment thereof.

6. That the City Clerk is hereby directed to cause a copy of this ordinance to be published once a week for two consecutive weeks in the Prichard Citizen, a newspaper published in the City in general circulation therein, the first insertion to be at least two weeks prior to June 20, 1952, the date herein set to hear objections, remonstrances, or protests respecting the improvements provided for herein.

7. That the City Clerk is hereby directed to have a copy of this ordinance sent by registered mail, postage prepaid, to each of the persons last assessing for city or county taxation the property which may be assessed for said improvements, each such copy to be mailed to each such person at this last known address not less than ten days prior to June 20, 1952.
